NCA YOUTH BASKETBALL TOURNAMENT RULES

- Double elimination bracket 2 game guarantee
 - Exception The Championship Game is FINAL
- Individual medals given to the winning team in each division.
- Balls will be provided for games only.
- No shooting during half time or between games by anyone not involved in the game in progress.
- All games will have 15-minute running clock halves. Clock will stop for injuries, and dead ball situations in the final 2 minutes of every game.
- Warm-up time will be 5 minutes.
- Halftime will be 3 minutes.
- If necessary, there will be an overtime period with a 3-minute running clock. Additional overtime periods will be 1-minute.
- Coaches will have 2 timeouts per half; one additional timeout during overtime periods.
- Timeouts will be 1 minute.
- Coaches and players should be ready to play 15 minutes before game start time.
- Teams placed in division of player in highest grade. Players may play up, but they cannot play down.
- Only <u>two</u> coaches will be permitted in the bench area.
- Only players shown on the roster are eligible to play.
- Players may only play on one team.
- Pressing and zone not allowed for grades 3-6 during the tournament.
- Pressing and zone allowed for grades 7-8.
- Tie Breaker for bracket winners:
 - o Tourney record
 - Winner of head-to-head game
 - Least points allowed in 1st half of all games
- Admission \$3/person. Children under age 12 free.
- Concessions will be available to purchase.
- Poor sportsmanship by any player, coach, or team may result in a game forfeit or elimination from the tournament.
- Profanity not tolerated from players, coaches, or fans. A double technical foul may be assessed and ejection from the tournament is likely.
- All decisions made by the referee, tournament coordinator, or any agent of the tournament are final.
- Teams will be responsible for any damage to school property. Any destruction of property will result in disqualification.
- North Central Schools shall not be held responsible for personal injury of any player; or for loss of team or individual property during the tournament.
